town-owned vehicles, and town parks; and requires restaurants to be smokefree. The ordinance does not cover all workplaces.

³ The city of Manning in Clarendon County passed an ordinance on July 18, 2011 that prohibits the use of tobacco products in city-owned buildings and city-owned vehicles. The ordinance does not cover all workplaces. ⁴The city of Greenville in Greenville County amended the ordinance on July 11, 2011 to include decks, patios, and porch dining; children's playground

areas in parks; and private clubs. The amendment also clarified the definition of a cigar bar. Changes took effect on August 1, 2011.

⁵ The city of Columbia ordinance was initially approved 11-8-06. Revisions to include protections for bar workers went into effect on May 21, 2008.
